WCCRC was not only successful with getting re-accredited, but we did so by being expedited through the Pre-Commission Review Report process as a result of not receiving any out-of-compliance ratings in any of the fundamental practice standards! This is an amazing accomplishment and is a true reflection of the high standards and dedication of the staff at WCCRC.

Another exciting highlight for the year was our return to our permanent location at 2772 East Broadway, now called THE LINK. As 2020 came to an end we left our temporary home on Kingsway to return to our beautiful and functional new home. The space has been completely redesigned and we look forward to the day we can fully and freely celebrate our new space together.

At this time we also wish to congratulate Pam Preston, Executive Director on her upcoming retirement in the spring of 2022! We wish to thank Pam for her dedicated leadership and significant contributions to Westcoast and we are looking forward to celebrating this milestone with her.

Our Pandemic Year:

The 2021 fiscal year started under some duress, as in response to the COVID 19 Pandemic, the staff started working from home in late March 2020. Many of our daily activities moved online. The Emergency Operations Centre at the City of Vancouver invited WCCRC to join the Emergency Child Care for Essential Workers Task Force. The Province was also implementing emergency child care measures involving the CCRRs in BC. Child Care was deemed an essential service.

During the year we were able to take advantage of several Federal Government COVID funding mechanisms including the Canada Emergency Wage Subsidy (CEWS) and the Canada Emergency Business Account (CEBA) loan program. Both funding streams have ensured our services have stability in rocky times.

Child Care As Essential Service

The Provincial and Federal Governments have begun implementing plans for universal \$10 a Day Child Care. Early care and learning is finally getting the recognition it deserves. However, as we begin to build this new system for early childhood care and education, we must work to ensure it includes well-paid and trained educators as well as environments that are central to the pedagogy of care and learning for young children. At the time of writing this report, we are heading into a Federal Election in September 2021. Child Care supporters remain ever vigilant in promoting and advocating for what is best for children and families in BC and beyond.

Accreditation 2020

We are proud to report that WCCRC achieved our re-Accreditation under COA in November of 2020. The Accreditation site visit and review were conducted virtually and for the first time, both of our Reviewers were from Canadian organizations. At this time I want to thank all of our community stakeholders including clients and funders who volunteered to be interviewed as part of our review process. We couldn't have done any of this work without you! Also thanks to the Board and the staff who put in an incredible amount of work to meet our obligations under COA Accreditation. We are grateful.

Relocation - AGAIN

At the end of December 2020, we moved back to our 2772 East Broadway location that had been undergoing a redesign and seismic upgrade since January 2019. The offices were not fully ready for us to provide services, but we moved our possessions and waited for the renovation to complete and the pandemic to subside. By April 2021 we were beginning to work on setting up the new offices under somewhat limited COVID re-opening restrictions. We hope to have more onsite access for all soon! We have a long-term lease in this location, so you will know where to find us for the next 20 years.



Report from the Executive Director

Special Projects

In 2019 Westcoast received funds for several one-time projects funded by the Government of Canada through the Canada BC Early Learning and Child Care Agreement. These projects were meant to be in place for one year, but several continued through 2020/21. Here are the highlights of these exciting projects:

Peer Mentoring Project for Early Childhood Educators in BC

- Led by Dr. Laura K. Doan in partnership with TRU (Thompson Rivers University)
- In support of the ongoing professional development needs of beginning and experienced ECE's, the project paired up Educators to share experiences and learn from each other, to become part of the collective voice and build effective networks of support.
- The project reached 200 ECEs in 17 BC communities and 20 skilled and dedicated facilitators. Learn more at Ecepeermentoring.trubox.ca.

ECE Professional Development Bursary Fund

- In support of improving access to training for ECEs and child care providers living in rural and remote communities; improving access to professional development for indigenous populations, and reducing financial barriers in accessing high-quality learning opportunities.
- Led by Principal Consultant Kathreen Riel in partnership with WCCRC; final report to be released in Fall of 2021.
- 3396 educators participated in 1031 locations;
 Distribution of bursary funds included 19% for individual bursary applicants, 19% for communities of practice, and 62% of the funding went to conferences and workshops;

Administration and Management for Child Care (AMCC)

- AMCC was originally planned to be an in-person training taking place all over BC with a network of local trainers. The pandemic transformed this work into an online course, offered either as a cohort (40 hours) or as self-paced learning (12 hours), with facilitators in communities across the province. Based on the original work known as the INFORM Guide, an online knowledge base has been developed as a comprehensive information and policy database for ECE leaders. It reflects current practices and learnings in inclusiveness, Truth and Reconciliation, the BC Early Learning Framework, and inquiry-based approaches.

BC Early Years Professional Development Hub

- As a one-stop online professional development hub for educators working within the BC early years sector, the Hub became established in partnership with early childhood organizations who were developing provincial projects with funding from the Federal ELCC initiative. The Hub has been an amazing offshoot of collaboration that was never in the original plans when the funding was granted.
- The partnership includes the Early Childhood Educators of BC, BC Family Child Care Association, the BC Early Childhood Pedagogy Network and most recently, BC Aboriginal Child Care Society;
- WCCRC is thrilled to be collaborating as part of this new initiative that hosts our Admin and Management for Child Care program. Find out more at: bcearlyyearshub.ca.
