As we worked hard in the Fall to layout our new strategic plan we looked ahead; acknowledging this new era of early years and its place at the forefront of the political agenda. After many engaging sessions and activities, we developed a strategic plan that would align our work and mission and guide us towards reimagining our financial potential and investing in our relationships to ensure our role as a leader in the field.
